## YOUR OPTIONS TO ACQUIRE SAMSON OIL & GAS LIMITED SHARES AT \$0.038 PER SHARE EXPIRE ON 31 MARCH 2017

We are writing to you as a registered holder of **31 March 2017** options in **SAMSON OIL & GAS LIMITED** to remind you that the options will expire at 5:00pm (WST) on **31 March 2017**.

Your option holding may be exercised in <u>whole or in part</u> by payment of \$0.038 for each option by no later than **31 March 2017**. If payment is not received by 5:00pm (WST) on **31 March 2017** the options will lapse and all rights under the options will cease at that time.

Some of the courses of action available to you as a holder of these soon to expire options are:

- a) Exercise the options on or before 31 March 2017.
- b) Sell your options. Quotation of the options will cease at the close of trading on 21 March 2017.
- c) Do nothing (ie, allow your options to expire). If you do not exercise or sell your options they will expire on **31 March 2017** and your right to subscribe for ordinary shares in **SAMSON OIL & GAS LIMITED** at \$0.038 per share will lapse.

There is no obligation on option holders to exercise their options. However, under paragraph 6.1 of Appendix 6A of the Australian Securities Exchange (ASX) Listing Rules, the Company is required to advise option holders of the information contained in this notice.

The market sale price of ordinary shares in **SAMSON OIL & GAS LIMITED** on ASX was \$0.004 on Thursday 2March 2017, being the last trading day in Perth prior to the date of this notice.

During the three (3) months preceding the date of this notice:

- the highest market sale price of ordinary shares on ASX was \$0.006 on 23 January 2017; and
- the lowest market sale price of ordinary shares on ASX was \$0.003 on 14 February 2017.
