Introduction

Site Group International (Site) is at an exciting stage of its development having identified both organic and inorganic growth opportunities.

Site has:

- **Recently completed the acquisition of Sun Coast Training and Accreditation - a Registered Training Organisation (RTO)**
- **Entered into an agreement to acquire Cyba Recruitment, a Philippines based labour sourcing group**
- **Identified and commenced negotiations for training facilities in Gladstone and Perth to service an expanding demand for skilled labour**

To fund these activities Site raised \$4 million through a fully subscribed Convertible Note Issuance in October 2011. Site is now providing existing shareholders with the opportunity to participate in a fully underwritten non-renounceable rights issue to raise \$4.2 million to fund the rollout and provide working capital

Funding Site's Growth

Completed a Convertible Note Issuance on 26 Oct 2011

- Raised \$4 million
 - Strong participation from board and management
 - All convertible note holders exercised their conversion rights at \$0.10/share by 31 October 2011.

Site announced a 1 for 4 Non-renounceable Rights Issue on 18 November 2011

- To raise \$4.2 million
 - Opportunity for existing shareholders to participate in the companies growth
 - The rights issue will be fully underwritten
 - Rights issue expected to close on 14 December 2011
- A prospectus will be distributed to all eligible shareholders

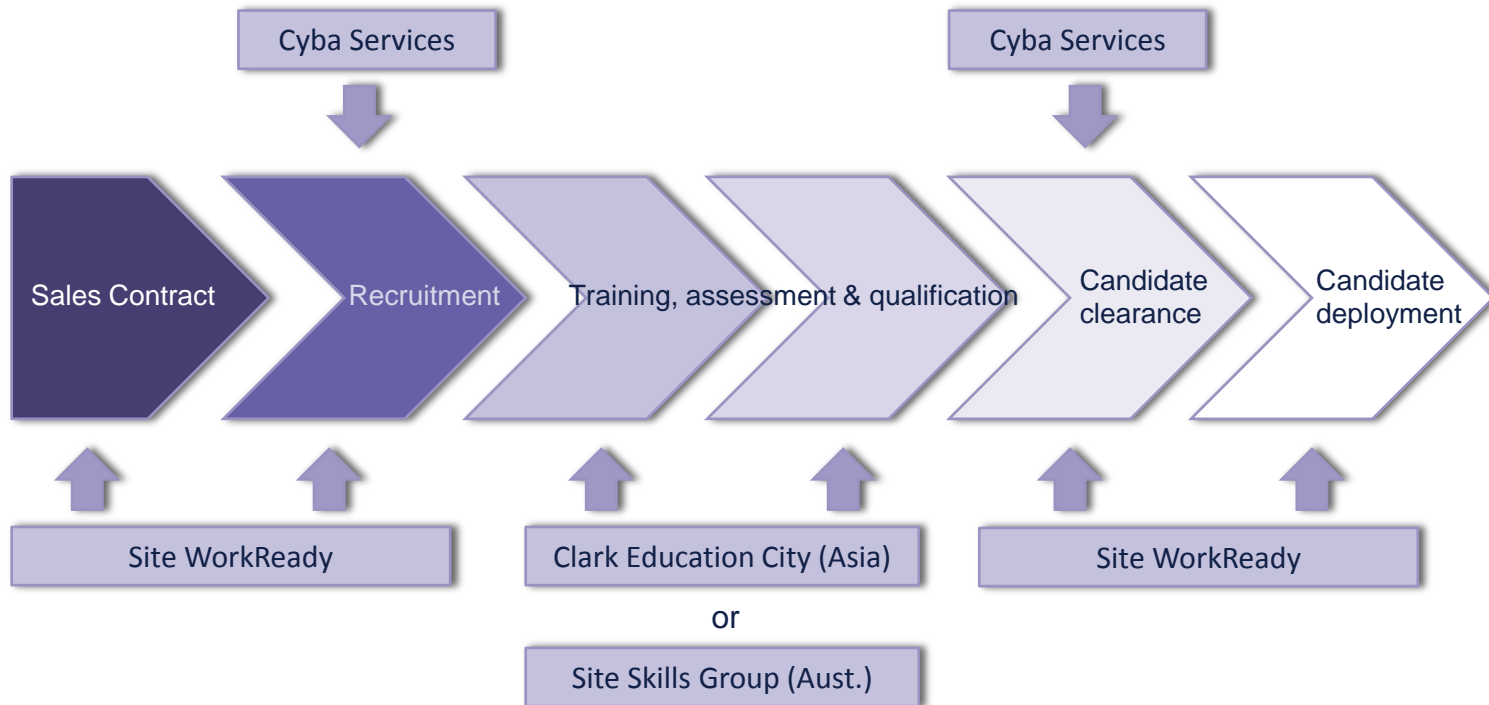
The acquisition of Sun Coast and operational rights and acquisition of Cyba Recruitment are expected to be earnings accretive in the first full year of operations

- Focus on providing end to end workforce and labour planning solutions to the resource and construction sectors where there are identified skills shortages both now and in the future

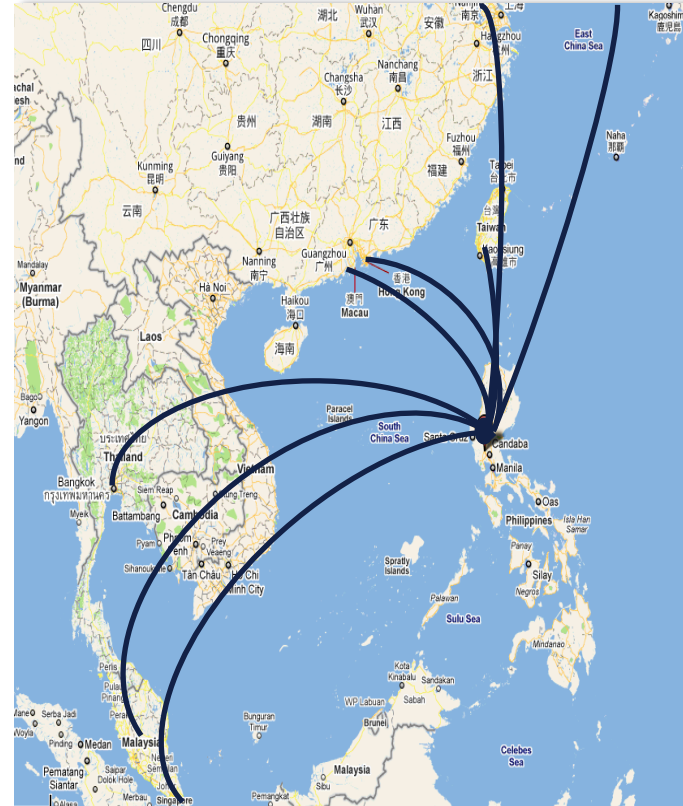
Investor Highlights

 - Growth by acquisition and establishment of training centres in the key growth markets of Queensland and Western Australia.

- Financial framework is as follows:
 - High margin business with low direct costs – diminishing marginal costs with scale
 - Overheads in Philippines relatively fixed up to \$20m turnover
 - Gross and Net Margin expansion occurs once fixed overheads recovered
 - Potential to retain candidates once assignments completed and redeploy to upcoming client requirements – lower cost and enhanced service

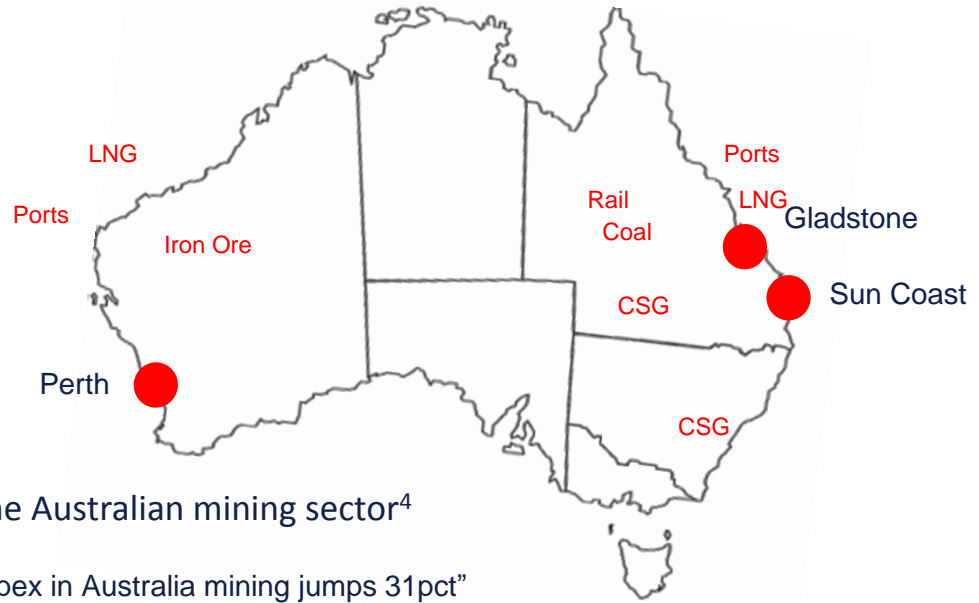
- **Skilled Labour Market – Supply and Demand**

- There is growing evidence that there is a looming employability crisis in certain regions with an undersupply of suitably qualified talent – in particular skilled tradesmen.
- One in three employers worldwide confirm they cannot find the talent they need to fill key vacancies within their organisation*
- In both 2010 and 2011 skilled trades workers were voted by employers to be in the top three most difficult jobs to fill*
- An aging workforce and high demand for skilled workers to deliver existing and new projects will continue to increase demand for skilled trades.
- Going forward employers must adopt a long term approach to their hiring needs involving dedicated workforce planning

Key Domestic Locations

- 60% of Australian resource sector employers reported that skilled labour shortages were their biggest concern¹
 - Shortage of 36,000 skilled tradespeople in the resources sector by 2015²
 - BHP predicts that Australia's resources industry will need an extra 170,000 workers in the next five years³
 - 4 Major CSG to LNG projects currently in the pipeline for Gladstone are expected to add 4,500-5,000 jobs each¹
 - As of April 2011 Australia had \$173.5 billion in planned CAPEX in advanced stage projects¹
 - 94 **advanced** stage projects

 - 20 infrastructure

Growth Agenda

- Site Group has identified a number of strategic locations where major resource projects are being developed and demand for skilled labour is high. Site is expanding services in these locations through strategic acquisitions and partnerships with significant industry leaders.

Potential Additional Growth

- WA Mining Academy – CAPEX spend by industry partners - management and training provided by Site

- Heavy Machinery Training facility to be established at Clark
- Expansion of training into PNG and Indonesia

Growth - Recruitment

- **Cyba Services**

- Site has taken a 2 year operating lease on Cyba with the right to acquire
- The agreement is by way of term sheet which is subject to formal documentation
- Performance based remuneration and incentive plan to remove upfront costs and minimise downside risk
- Streamlines existing arrangement between the two companies to reduce operating costs
- Cyba Services will continue to source candidates but will train and process all candidates through Site
- Cyba Services is experienced in processing candidates for immigration and visa applications both in Australia and the Philippines
- Growth potential
 - Increase in customer demand through increased access to appropriately skilled Filipino candidates
 - Can now build volume as candidates can be assessed and up-skilled through Clark Education City

Growth – Aust. Training Facilities

Acquisition of Sun Coast Training and Accreditation (RTO)

- Successful and profitable
- Provides additional training scope for Site Group's training facilities
- Site will value add to existing business through broadening training and assessment scope and improve customer volume

Perth

- Training facility based in Perth to cater to the resources industry and potentially the oil and gas industry.
- Site has identified a significant market opportunity to train students for the well documented skill shortage.
- Provide industry specific trained candidates who are then placed into the vast number of mining and oil & gas companies in Western Australia

Gladstone

- Focus on oil & gas and resources HSE training
- Shortage of training facilities
- Huge industry demand
- Four major gas projects
- Two coal export projects



Growth – International Training Facilities

Oil & Gas Facility

- Site is currently in negotiation with a major oil and gas company on a potential training centre within the Clark Education City facility.
- The Clark Education City facility would receive a significant capital injection to build the required additional facilities and provide the relevant training equipment with no upfront CAPEX or additional fixed costs for Site.
- The new oil and gas facility would be operated and managed by Site
- Running costs should be optimised through synergies with the existing CEC campus and staff.
- Expected to be operational by June 2012

Heavy Machinery Facility

- Existing need by major global heavy equipment supplier
- Global shortage of trainees and operators
- Large secondary market requirement

Growth – Facility Management

WA Mining Academy

- The WA mining academy is a proposed industry venture where an existing regional campus will be constructed as a training facility with live in accommodation. The academy will replicate a mine campsite and will be used to train both aspiring candidates and up-skill existing workers
- Site would manage the proposed facility and train candidates on a preferred basis for the stakeholders. Additionally Site will seek government funding for training workers in industries facing skills shortages.
- This training model utilises Site's core competencies creating a fee for service revenue stream.
