Board renewal process continues at WPG

WPG Resources Ltd (ASX: WPG) is pleased to advise the appointment Ms Helen Wiseman as Lead Independent Director and Mr Cornel Parshotam as an Alternate Director to Mr Gary Jones (who lives in New Zealand) as of 1 March 2017.

Late last year the Directors agreed to appoint one of its independent non-executive Directors as Lead Independent Director who can oversee the executives of the Company and set a pro-shareholder agenda without the management conflicts that an executive insider sometimes faces. A Charter for this new position has been developed and adopted. Helen Wiseman who was appointed as a non-executive director on 20 October 2016 was today nominated by the independent non-executive directors and will act as Lead Independent Director.

Cornel Parshotam is the Company's Chief Operating Officer. He has held a broad range of senior management positions in underground and open pit gold and base metal mining operations and processing in Africa and Australasia, at scales varying from small to large. Prior to joining WPG he was Head of Operations at BHP Billiton's Olympic Dam mine in South Australia. Prior to that, he was the General Manager Mine at Olympic Dam.

WPG's Executive Chairman Bob Duffin said "As an Alternate to Gary, Cornel's technical, operational and business knowledge ties in very effectively to the collective skills of our Board."
