Capital commitment

At 28 February 2017, US Select Private Opportunities Fund III, L.P. (**LP**) has called US\$13.0 million (or 17.8% of capital committed). The Fund's proportionate share is approximately US\$9.4 million (a 72.5% share).

Drawdowns

During the month, the LP received a drawdown request from Elephant Partners Fund I, L.P. for a total consideration of US\$0.5 million.

At 28 February 2017, net drawdown requests received from underlying investments total approximately US\$10.3 million.
