SHARES TO BE RELEASED FROM ASX RESTRICTION

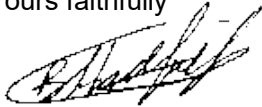
Wellington, New Zealand, 28 March 2017: Volpara Health Technologies Limited ("Volpara", ASX:VHT) advises that 11,864,511 ordinary shares are due to be released from compulsory ASX restriction on 12 April 2017.

Following the release of the shares Volpara has a total of 142,644,785 ordinary shares on issue, 94,010,908 of which will be quoted on ASX. It also has 14,084,498 unlisted options on issue.

An Appendix 3B seeking quotation of the 11,864,511 ordinary shares to be released from ASX restriction is attached.

In addition to the shares under ASX restriction a further 33,691,980 ordinary shares will be released from voluntary escrow on 27 April 2017. These shares are already quoted by ASX and accordingly no Appendix 3B is required on the release of these shares.

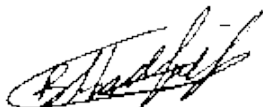
