Commentary for the quarter ending 31 March, 2017 FarmaForce Limited

The period ending 31 March, 2017, continues with a significant and sustainable increase in customer receipts.

The cumulative key results are:

- An **increase of 87% in receipts** from customers, represented by \$2,812K for the nine months ended 31 March, 2017, compared to \$1,504K for the nine months ending 31 March, 2016.
- A **\$1,823K improvement of net cash used in operating activities** represented by (\$1,099K) in the nine months ended 31 March, 2017, compared to (\$2,923K) for the nine months ending 31 March, 2016.
- FarmaForce continues to maintain a financial position of **zero external debt**.

FarmaForce Limited continues to increase its presence within the pharmaceutical industry and engage new multinational clients as well as gain new contracts from existing clients.
