Change of Directors

Yancoal Australia Ltd ("Yancoal") is pleased to announce the appointment of Mr. Xiangqian Wu and Mr. Qingchun Zhao as Non-Executive Directors of Yancoal.

The appointment of Mr. Wu and Mr. Zhao follow the resignation of Mr. Boyun Xu and Mr. Yuxiang Wu, effective 28 April 2017.

Mr. Wu is a Research Fellow in Applied Engineering Technology, a Doctor of Engineering, and a Director and General Manager of Yanzhou Coal Mining Company ("Yanzhou").

Mr. Wu joined Yanzhou's predecessor in 1988. In 2003, he was appointed as the Deputy Head of Jining No.3 Coal Mine of Yanzhou. Mr. Zhao is a senior accountant with an EMBA degree, and is a Director and the Chief Financial Officer of Yanzhou.

Mr. Zhao joined Yanzhou's predecessor in 1989 and was appointed as the Chief Accountant of the Finance Department in 2002 and Director of the Planning and Finance Department of Yanzhou in 2006.
