Trade Finance Loan Book & Compliance as at 30 April 2017

In accordance with the Corporate Bond Issue Information Memorandums released to the ASX on 18 May 2015, 24 March 2016 and 18 May 2016, CML Group (ASX code: CGR) wish to advise that as at 30 April 2017 it was compliant with all Financial Covenants contained within the Memorandums. The calculations are tabled below.

At the end of April 2017 CML had a trade finance loan book of over \$112.1m (March 2017: \$101.1m), of which it had supplied actual funding of \$66.4m (March 2017: \$64.3m). This represents a Loan to Value ratio of 59.2% (March 2017: 63.6%).

Please note all Financial Covenant definitions are contained in the Information Memorandum released to the ASX on 18 May 2015, 24 March 2016 and 18 May 2016.

The information contained in this release relates only to the component of CML Group's finance business that is funded by Corporate Bonds. The purpose of this release is to confirm compliance with Corporate Bond Covenants and should not be relied upon as an indicator of business growth or overall performance.
