Rights Issue Offer - Notification of the Shortfall

Sydney, Australia – Simavita Limited (**Simavita** or the **Company**) (ASX: SVA) advises that its partially underwritten 1 for 7 non-renounceable Rights Issue ("Entitlement Offer") closed on Monday, 22 May 2017.

Results of the Offer

The Company is pleased to announce that it received applications under the Entitlement Offer for a total of 4,709,734 CHESS Depositary Interests ("New CDIs"). Eligible holders took up a total of 2,395,224 New CDIs under their entitlements together with 2,314,510 additional CDIs granted to eligible holders under the shortfall offer. The total subscription amount received by the Company on accepted applications was \$188,389. These results are subject to any cheque dishonours.

Underwritten Shares

In accordance with the underwriting agreement dated 3 May 2017 the underwriter, Lodge Corporate Pty Ltd, will take up a total of 16,493,000 New CDIs at a total subscription price of \$659,720 ("Underwritten Securities"). The Underwritten Securities will be issued to the underwriter and sub-underwriters in accordance with the terms of the underwriting agreement.

Notification of Shortfall

Pursuant to ASX Listing Rule 7.40 and Appendix 7A, the Company hereby gives notice of a total shortfall of 14,682,921 New CDIs after completion of the rights issue and allocation of the Underwritten Securities ("Shortfall Securities"). The Board reserves the right to issue any of the Shortfall Securities at their discretion within 3 months after the Entitlement Offer closing date.
