**Issue of shares to Director under employee incentive Scheme: Mr. John Abernethy**

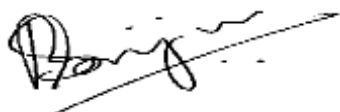
During the 2016 Annual General Meeting shareholders of the Company approved the issue of shares in the Company to Mr. John Abernethy, an Executive Director of the Company on the terms of the current employee incentive scheme operated by the company and approved by the Company's 2007 Annual General Meeting.

The main features of the scheme include that shares are issued at market price and the related loan liability is paid for by staff over a deferred term, usually 3 years.

The Board of the Company has granted 200,000 shares to Mr. Abernethy. The shares are granted at the current market price of \$0.50 being the volume weighted average market price over the 5 trading days before the date of the issue.

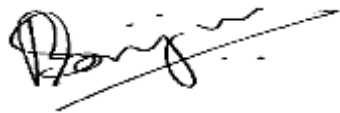
