#### SENSEN NETWORKS: "SenSen Awarded NSW Government Roads and Maritime Services Panel Contract"

Orpheus Energy Limited ("Orpheus") is pleased to refer shareholders to the attached Media Release by SenSen Networks Pty Ltd ("SenSen") regarding the awarding of a new panel contract to SenSen, for the Supply, Installation, Maintenance and Certification Services of Detection and Enforcement Camera Systems for the NSW Government Roads and Maritime Services.

As announced on 12 April 2017, Orpheus has entered into a Share Purchase Agreement with all of the shareholders of SenSen and is currently in the formal due diligence period. Subject to compliance with regulatory requirements and approvals as may be required under Australian law including the ASX Listing Rules. Orpheus will acquire 100% of SenSen by the purchase of all the shares in SenSen from the shareholders of SenSen, in exchange for the issue of shares in Orpheus (Acquisition). This Acquisition will proceed as a backdoor listing.

Please refer to the ASX announcement dated 12 April 2017 for further detail on SenSen; the Acquisition; consideration for the Acquisition; conditions precedent to the Acquisition: indicative capital structure as a result of the Acquisition; the proposed board and management of the combined Orpheus and SenSen Group; and the anticipated timetable for the Acquisition.

Any offer of securities by Orpheus as part of the backdoor listing will be accompanied by a prospectus in compliance with the Corporations Act. Any potential investor will need to consider the prospectus in deciding whether to apply for securities and can only acquire securities by completing an application form accompanying the prospectus. It is anticipated that the prospectus will be lodged with ASIC in the near term.

## SenSen Awarded NSW Government Roads and Maritime Services Panel Contract
