## **Notes to be read in conjunction with the Appendix 4C for the quarter ended 30 June 2017**

### **Factors to Consider in Assessing the Company's Cash Position**

There are a number of factors that should be taken into account in assessing the Company's cash position, the main factors being:

#### ***Reorganisation of operations and negotiations with customers***

The Company is in the process of reorganising its operations, and negotiating with its customers, to position the business so that its net operating cash flows are consistently positive.

#### ***Exploring options to revitalise operations***

The Company has taken steps to explore options to revitalise its operations, all of which involve raising further cash to fund its future operations. This includes the proposed transaction with PYO Travel (MY) Sdn Bhd, as announced on 13 May 2015, which is still being negotiated, and under consideration.

#### ***Continued financial support from directors and major shareholders***

Over the past few years, the Company's directors and major shareholders have continued to fund anticipated cash shortfalls. The directors and major shareholders have committed to continue meeting any future cash shortfalls, by way of interest free loans, if and when required.

In taking the above factors into consideration, the Company is confident that it will have sufficient cash to fund its business activities going forward.
