ASX ANNOUNCEMENT

Correction to Appendix 3B

UraniumSA Limited ACN 148 162 092 (ASX Code: USA) refers to an Appendix 3B announced to the ASX on 3 July 2017 and advises a correction to the entity's placement capacity under ASX listing rule 7.1 and 7.1A from that notice.

The entity's remaining issue capacity under listing rule 7.1 and listing rule 7.1A was stated at section 6i as 10,470,546 and 34,902,767 respectively. The correct capacity under number under listing rule 7.1 and listing rule 7.1A should be 18,386,692 and 35,591,128.

The capacity under listing rule 7.1 number was previously reduced by the issue of 6,883,605 shares in the Company to the Lender, on 6 March 2017, following the conversion of \$55,000 of outstanding debt into shares, pursuant to the terms and conditions of the Funding Facility announced to ASX on 30th April 2015. At the Company's Extraordinary General Meeting held on 22 June 2016, members voted in favour of Resolution 4 - Approval to issue shares up to \$300,000, allowing the company to issue these shares without using the Company's 15% annual placement capacity.

Attached to this announcement a new Appendix 3B that reflects the above correction.
