Operations

Byte Power Group Ltd (“BPG”) continues to develop its IT&T segment through its partnership with Wimobilize Singapore Pte Ltd in Singapore, Malaysia, Australia, New Zealand, Hong Kong, Macau, China and Taiwan.

BPG, through the recently announced partnership between its subsidiary Byte Power Pty Ltd and Soar Labs Pte Ltd is progressing the formation of its cryptocurrency exchange in Australia following the completion of the subscription agreement on the 23rd June 2017.

BPG will continue to explore new and existing business opportunities for the wine distribution businesses in Asian markets, particularly with its 8 Eagles range.

The Company expects existing trade receivables to continue to support working capital requirements of the Company as it continues to develop business and sales opportunities.
