Astro Japan Property Group - Trading Halt Request

Pursuant to Listing Rule 17.1, Astro Japan Property Group (ASX: AJA) (**Astro Group**) requests a trading halt in its ordinary stapled securities from the commencement of trading today, Tuesday 1 August 2017.

In accordance with Listing Rule 17.1, we advise:

- the trading halt is necessary for Astro Group to make an announcement to the market in relation to a proposed transaction involving the disposal of its assets (**Transaction**) expected to be announced today;
- Astro Group wishes the trading halt to remain in place until the earlier of such time as it
 makes an announcement to the market in relation to the Transaction, and the
 commencement of trading on Thursday 3 August 2017; and
- Astro Group is not aware of any reason why the trading halt should not be granted or of any
 other information necessary to inform the market about the trading halt.
