Update to Timetable for Demerger and Jimmy Crow Prospectus

Trustees Australia Directors advise an updated timetable for the series of transactions leading to the Completion of the Jimmy Crow Demerger and the Cashwerkz Merger / Acquisition following the approval of all resolutions at the General Meeting of the Company on 31 July 2017.

Additionally, it was advised in the Notice of Meeting lodged with ASIC on 30 June 2017 in respect of Resolutions 4 and 5 in respect of Director Placements to Michael Hackett and Adcock Private Equity that it was intended to make the Director Placements at the same time and at the same price as the intended Placement to new subscribers, which was planned to take place in approximately 3 months after the General Meeting date.

Under ASX rules for related party issues of securities, the maximum period is normally 1 month.

It was further advised that an application had been made to ASX for a waiver to extend that period to 3 months.

ASX has declined that waiver request and requires that the placement be made within 1 month.
