The weekly estimated unaudited pre-tax net asset value before withholding tax on unpaid distributions as at 28 July 2017 was \$1.55* per unit.

The Fund is a long-term investor and does not intend to dispose of its total portfolio. If estimated tax at 35% on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value before withholding tax on unpaid distributions as at 28 July 2017 would be \$1.33* per unit.

The Fund is in the process of finalising its half-yearly property portfolio valuation exercise. The independent appraisal and property valuation will be included in the 30 June 2017 half year financial report. Accordingly, the NAV as at 28 July of \$1.55 per unit does not take into account any potential changes to the property portfolio fair value that might arise from that revaluation exercise.

These estimates may not take into account all intra-month accruals, which are incorporated in the monthly NTA updates.
