Under the Sims Metal Management Long Term Incentive Plan (“SimsMM Plan”), participants may be granted performance rights, which are the right to receive an ordinary share in the entity upon satisfaction of vesting conditions for a nil issue price. For these performance rights to vest the entity needs to achieve an earnings performance hurdle based, in respect of 414,974 performance rights and 570,348 performance rights respectively, on the entity’s FY18 ROIC or FY19 ROIC, respectively.

If these performance hurdles are met, and the participant remains in the employ of the entity or a related party, or has ceased to be an employee as a result of a ‘qualifying cessation’, then ordinary shares will be issued on either 30 August 2018 or 30 August 2019, as the case may be. If the particular performance hurdle is not met then the performance rights will lapse.

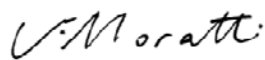
