SAUNDERS INTERNATIONAL SECURES NEW CONTRACTS VALUED AT \$23 MILLION

Sydney – Tuesday, 8th August 2017

Saunders International Ltd (ASX:SND) is pleased to announce that it has, over the last 3 months, secured new contracts valued at approximately \$23 million.

Three new contracts have been awarded to our Engineering & Construction group with an approximate value of \$17 million:

- Mobil New Guinea Port Moresby, EPC Terminal Upgrade
- Lihir Gold Limited PNG, Leech Tanks Replacement
- Mobil Oil Australia, Structural Mechanical Piping (SMP), Electrical and Instrumentation (E&I)
 Project

Following an earlier strategic decision to seek opportunities in PNG, we are pleased to have secured the two PNG contracts which will generate a combined revenue of approximately \$12 million. The projects include EPC of new tanks and related facilities in this new geographical sector for SND.

The Mobil Victoria contract is for a large Structural Mechanical Piping project. This circa \$5 million contract is in addition to, but on the same site as, the previously advised tank construction project for Mobil which is already underway.

Four new contracts are in final stages of negotiation for our recently acquired Saunders Civilbuild Group, with an approximate value of \$5 million. These contracts are for the construction of three road bridges and one rail bridge, including the supply of precast super T structural beams.

Saunders Civilbuild has also been successful in winning the \$1 million civil component of a tank construction project currently being undertaken by our Engineering Construction division. This is the first project being undertaken in conjunction with another division of the Saunders group.
