Offer Opens

Walsh & Company Investments Limited (**Responsible Entity**), as Responsible Entity for US Select Private Opportunities Fund III (**Fund**), is pleased to announce a capital raising for Units in the Fund. Since the establishment of the platform, the three limited partnerships in the Series have collectively committed over US\$230 million across 28 US-based small-to-mid-sized private investment funds. These underlying funds, in turn, have invested in over 150 companies, providing investors with a diversified portfolio of investments in US-based operating businesses managed by high quality US-focused private investment fund managers.
