NTA update

The estimated unaudited net tangible asset value before withholding tax on unpaid distributions at 31 July 2017 was \$1.78* per unit (30 June 2017 was \$1.86* per unit).

The Fund is a long-term investor and seeks to make investments in a tax-effective manner. If tax at 35% on estimated underlying investment values were to be recognised, the estimated unaudited net asset backing after tax as at 31 July 2017 would be \$1.76* per unit.

Fund update

Capital commitment

At 31 July 2017, US Select Private Opportunities Fund, L.P. (**LP**) has called US\$57.5 million (or 82.7% of capital committed). The Fund's proportionate share is approximately US\$49.2 million (an 85.5% share).

Drawdowns

During the month, the LP did not receive any drawdown requests and capital returns.

At 31 July 2017, net drawdown requests from underlying investments were approximately US\$58.2 million (or 83.3% of total funds committed by the LP).
