Directors' Report

Your directors submit their report together with the consolidated interim financial report for the half year ended 30 June 2017.

REVIEW AND RESULTS OF OPERATIONS

The ChongHerr Group sales revenue for the half year was \$487,610 (2016: \$529,726), a fall of 8% from the comparative half year. The consolidated operating result after income tax for the half year is a loss of \$290,205 against a profit of \$73,144 in the previous half year. The adverse result is mainly due to the write off of capitalised previously capitalised exploration and evaluation assets amounting to \$179,566, arising from the expiration and relinquishment of exploration permit EPM 11005.

During the period of review, no sandstone blocks have been exported and all the revenue is derived from the domestic market. There are however signs of recovery in demand of sandstone from overseas, especially the Chinese market, in the second half of the financial year.

The company's cash position remains tight and directors are closely monitoring the company's liquidity and financial performance. The ability of the Group to continue as a going concern is principally dependent upon:

- The ability of the group to meet its forecast revenue figures;
- The collection of amounts receivable, including amounts past due but not impaired;
- The ability of the group to manage its cashflows to ensure that it is able to meet its debts as they fall due; and/ or
- The ability of the group to manage its creditors within the available credit terms.

These conditions give rise to material uncertainty which may cast significant doubt over the group's ability to continue as a going concern.

The directors believe that the going concern basis of preparation is appropriate due to the following reasons:

- The directors expect that trade receivables will be collected in an agreed timeframe; and
- The directors closely monitor the group's cash flow projections and working capital position and expect to meet the forecasted revenue and cash flow results. The directors believe that these are sufficient to continue to fund the Group's working capital requirements.

Should the Group be unable to continue as a going concern, it may be required to realise its assets and extinguish its liabilities other than in the ordinary course of business, and at amounts that differ from those stated in the financial statements.

SANDSTONE QUARRYING AND PRODUCTION

During the period of review, the quarry produced 1,400 tons of premier quality boulders and blocks. The sandstone boulders are supplied for the building and construction industry in the local market and sandstone blocks are mostly exported to China for luxury development projects.

The production is expected to grow, meeting both the local and overseas markets in the second half of the financial year.

Production generated through the company's sub-contractor has slowed down and the group has been notified of its departure in the second half of the financial year.

LIKELY DEVELOPMENTS AND EXPECTED RESULTS

The directors are carefully monitoring ChongHerr's financial performance and position. Additionally, in the coming year the company will maintain its focus on sales opportunities in China and South East Asia, and production/quarrying efficiencies. Demand for sandstone is expected to remain strong, in both local and overseas markets.

The company will also continue to conduct its business so that profitability can be enhanced and the balance sheet strengthened.

1 BASIS OF PREPARATION

The consolidated interim financial statements cover the consolidated entity of ChongHerr Investments Ltd and its controlled entity (the “ChongHerr Group”). ChongHerr Investments Ltd is a listed public company incorporated and domiciled in Australia.

The consolidated financial statements of the Group as at and for the year end 31 December 2016 are available upon request from the Company’s secretary by calling Tel: +617 3711 2088, emailing: info@chongherr.com.au or mailing to P O Box 3584, Sunnybank South 4109, Queensland.

These financial statements were authorised for issue by the Board of Directors on 25 August 2017.

(a) Statement of compliance

These general purpose interim financial statements for the half-year reporting period ended 30 June 2017 have been prepared in accordance with requirements of the Corporations Act 2001 and Australian Accounting Standard AASB 134: Interim Financial Reporting. The Group is a for-profit entity for financial reporting purposes under Australian Accounting Standards.

This interim financial report is intended to provide users with an update on the latest annual financial statements of ChongHerr Investments Ltd. As such, it does not contain information that represents relatively insignificant changes occurring during the half-year within the Group. It is therefore recommended that this financial report be read in conjunction with the annual financial statements of the Group for the year ended 31 December 2016, together with any public announcements made during the following half-year.

(b) Accounting Policies

The same accounting policies and methods of computation have been followed in this interim financial report as were applied in the most recent annual financial statements. The impacts of accounting standard issued but not yet effective is not considered to be material except in relation to some of the matters discussed at Note 1(c) below.

(c) New and Revised Accounting Requirements Applicable to the Current Half-year Reporting Period

The Group has adopted all of the new, revised or amending Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period. The adoption of these Accounting Standards and Interpretations did not have any significant impact on the financial performance or position of the Group.

Any new, revised or amending Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

(d) Going Concern

The Group made a net loss of \$290,205 for the half-year ended 30 June 2017. As at 30 June 2017 the Group has a net cash reserve of -\$29,672 (overdraft), net current assets of \$151,599 and net assets of \$2,369,979

Included in current assets, there are some trade receivables (totalling \$213,058) past due normal trading terms of 90 days and not impaired. The Directors closely monitor trading and the collection of those amounts owing.

The ability of the Group to continue as a going concern is principally dependent upon:

- The ability of the group to meet its forecast revenue figures;
- The collection of amounts receivable, including amounts past due but not impaired;
- The ability of the group to manage its cashflows to ensure that it is able to meet its liabilities as they fall due; and/ or
- The ability of the group to manage its creditors within the available credit terms.

These conditions give rise to uncertainty which may cast significant doubt over the group's ability to continue as a going concern.

The directors believe that the going concern basis of preparation is appropriate due to the following reasons:

- The directors expect that trade receivables will be collected in an agreed timeframe; and

Report on the Half-Year Financial Report

Conclusion

Emphasis of matter

Without modifying our conclusion, we draw attention to Note 1(d) in the half year financial report, which indicates that the ability of the company and the consolidated entity to continue as a going concern is principally dependent upon meeting forecast revenue figures, the collection of receivables, and the ability to manage cashflows. These matters, along with other issues as set out in Note 1, indicate the existence of a material uncertainty that may cast significant doubt about the ability to continue as a going concern so that it may not be able to realise its assets and discharge its liabilities in the normal course of business.
