- 3. Each party agrees that they will not sell or enter into any option or derivative transaction in relation to, or take any similar action in relation to (or agree or offer to do any of the foregoing), any of their Shares (a "Sale") without the written consent of the holders of at least 75% of the aggregate number of Shares held by the parties.
- 4. If any party is approached or has discussions or correspondence in relation to any Sale or potential Sale of any of their Shares, the party will promptly provide details (identity of buyer, price and material terms) to each other party.
- 5. The parties agree that they will act cooperatively with each other in their discussions with a view of maximising the price of any Sale of Shares.
- 6. The parties agree in principle that if an approach or offer is made for less than all of the Shares, the parties will seek to agree to sell their Shares proportionately.

- 7. Any party may terminate its participation in this agreement on 7 days written notice to each other party. Such termination will not affect the operation of this agreement as between the remaining parties.
- 8. This agreement is governed by the laws of New South Wales.
