## 360 Capital Total Return Fund (TOT) Investment Update

360 Capital FM Limited as responsible entity for 360 Capital Total Return Fund (the Fund or TOT) is pleased to advise that in line with its strategy, the Fund has committed to deploying \$26.6 million across two separate loan investments, comprising a \$7.1 million, junior debt investment on a commercial development in Perth and a \$19.5 million, senior debt investment in Sydney. These two investments are forecast to generate an average Internal Rate of Return (IRR) of approximately 17% p.a.

The Fund, through Australian Mezzanine Finance Pty Limited (AMF) continues to identify a significant pipeline of debt investment opportunities across key metropolitan markets with approximately \$35.0 million of live transactions currently in various stages of due diligence/negotiation. The Fund anticipates deploying the balance of available capital this calendar year.

The Fund has reviewed over \$400 million of transactions over the past three months and remains selective and disciplined when assessing debt investment opportunities. With further tightening of real estate credit markets anticipated, we expect that the volumes of these investment opportunities will continue to increase for the foreseeable future.

Based on the current committed investments and live transactions under review/negotiation, the Fund provides target earnings (including trading profits) for FY18 of between 9.0 to 12.0 cents per security.

In line with its distribution policy, the Fund will continue to distribute 100% of operating earnings and where appropriate, trading profits. Distribution guidance for the September quarter is 2.25 cents per security.
