#### Market overview

The S&P/ASX Small Ordinaries Accumulation Index finished 2.7% higher for the month on the back of a mixed reporting season.

Overall, earnings growth was the best in many years although a number of companies fell short of the market's elevated expectations. Most companies provided subdued outlook statements reflecting current economic conditions.

We were pleased to see strong performance from the small-cap sector and believe headwinds facing small-caps have abated following a difficult 12 months. The rebound of the resources and mining services sectors was also a standout, outperforming analysts' expectations. We believe the current equity market is fairly valued and we are well positioned to take advantage of opportunities as they emerge.
