**Astro Japan Property Group – Suspension Request**

Pursuant to Listing Rule 17.2, Astro Japan Property Group (ASX:AJA) (**Astro Group**) requests a suspension of its securities from the time on which it is announced that Astro Group securityholders have approved the resolutions required to give effect to the sale of Astro Group's TK Interests (**Transaction**) (on Wednesday 13 September 2017).

In accordance with Listing Rule 17.2, we advise:

- (a) Astro Group securityholders have approved resolutions giving effect to the Transaction;
- (b) as noted in the Explanatory Memorandum for the Transaction the suspension is necessary to avoid issues with the administration of the respective registers of Astro Japan Property Group Limited and Astro Japan Trust to allow the orderly distribution of proceeds to securityholders under the Transaction;
- (c) Astro Group wishes the suspension to remain in place until the earlier of:
  - (i) the date on which Astro Group announces that the Transaction has been terminated due to failure to satisfy any outstanding conditions as set out in the Explanatory Memorandum; and
  - (ii) Astro Group is removed from the official list following the completion of the Transaction; and
- (d) Astro Group is not aware of any reason why the suspension should not be granted or of any other information necessary to inform the market about the suspension which has not already been identified in the Explanatory Memorandum.
