NTA update

The estimated unaudited net tangible asset value before withholding tax on unpaid distributions at 31 August 2017 was \$1.44* per unit (31 July 2017 was \$1.42* per unit).

Fund update

Capital commitment

At 31 August 2017, US Select Private Opportunities Fund III, L.P. (**LP**) has called US\$21.4 million (or 25.0% of capital committed). The Fund's proportionate share is approximately US\$13.3 million (a 61.8% share).

Drawdowns

During the month, the LP received drawdown requests from Elephant Partners Fund I, L.P., Incline Equity Partners IV, L.P. and Luminate Capital Partners, L.P. for a total consideration of US\$1.7 million.

At 31 August 2017, net drawdown requests received from underlying investments were approximately US\$16.9 million.
