

COMPLETION OF CAPITAL RAISING

Diatreme Resources Limited ("Diatreme" or "the Company") (ASX: DRX) is pleased to announce that it has completed the recent capital raising program announced on 31 July 2017 with the company receiving the proceeds of \$750,000.

Accordingly Diatreme has now issued the following:

- a total of 56,509,902 fully paid ordinary shares ('Placement Shares') at an issue price of \$0.010 per share and 75,000,000 unlisted options with an exercise price of \$0.012 per option and expiry date of 28 February 2018 ('Placement Options") pursuant to ASX Listing Rule 7.1, and
- 18,490,098 fully paid ordinary shares ('Placement Shares') at an issue price of \$0.010 per share pursuant to Listing Rule 7.1A.
