To receive and consider the Company's Annual Financial Report, including the Directors' Report and Auditor's Report for the year ended 30 June 2017.

This item of ordinary business is for discussion only and is not a resolution.

1. Adoption of Remuneration Report

To consider, and if thought fit, to pass the following resolution as an **ordinary resolution**:

"That the Company adopt the Remuneration Report contained in the Company's Annual Financial Report for the year ended 30 June 2017 in accordance with Section 250R(2) of the Corporations Act."

Notes:

- (a) The vote on this Resolution is advisory only and does not bind the Directors or the Company;
- (b) The Company's KMP Members and their closely related parties must not cast a vote on the Remuneration Report unless they are appointed in writing as a proxy for a member eligible to vote on the resolution and that proxy specifies how to vote on the resolution,
- (c) The Chairman will vote all undirected proxies in favour of this resolution. If you wish to vote "against" or "abstain" you should mark the relevant box in the attached proxy form.

2. Re-election of Anton Tagliaferro as a Director

To consider, and if thought fit, to pass the following resolution as an **ordinary resolution**:

"That Anton Tagliaferro, who retires by rotation in accordance with the Company's Constitution and, being eligible for re-election, be re-elected as a Director."

Note: Without limitation, Rule 15.6 of the Company's Constitution is relevant to this Resolution 2.

The Chairman intends to vote undirected proxies in favour of this Resolution 2.

3. Ratification of Prior Issue of Shares

To consider, and if thought fit, to pass the following resolution as an **ordinary resolution**:

"That for the purposes of ASX Listing Rule 7.4 and for all other purposes, the Shareholders ratify the allotment and prior issue of:

- a) 28,688,524 fully paid ordinary shares issued on 21 March 2017;
 and
- b) 4,537,787 fully paid ordinary shares issued on 7 April 2017,

on the terms and conditions described in the Explanatory Statement which accompanies and forms part of this Notice of Meeting."

The Chairman intends to vote undirected proxies in favour of this Resolution 3.

Other business

To consider any other business that may lawfully be brought forward in accordance with the Constitution of the Company or the law.

Voting exclusions

Resolution 1 is indirectly connected with the remuneration of members of the key management personnel of the Company (including the Directors), whose remuneration details are included in the Remuneration Report (KMP Members). In accordance with the requirements of the Corporations Act 2001 (Cth) (Corporations Act) the Company will disregard any votes cast (in any capacity) on Resolution 1 by or on behalf of:

- · a KMP Member other than the Chairman; and
- a closely related party of those persons (such as close family members and any companies the person controls).

unless the vote is cast as proxy for a person entitled to vote in accordance with a direction on the proxy form.

In regard to votes cast by the Chairman as proxy for a person entitled to vote in accordance with a direction on the proxy form, the Company will not disregard such votes by the Chairman provided that the appointment expressly authorises the Chairman to exercise the proxy even though the Resolution is connected directly or indirectly with the remuneration of a KMP Member.



What this means for Shareholders: If you intend to appoint a KMP Member (such as one of the Directors) as your proxy, please ensure that you direct them how to vote on Resolution 1. If you appoint the Chairman as your proxy, and you do not direct your proxy how to vote on Resolution 1 on the proxy form, you will be expressly authorising the Chairman of the Meeting to exercise the proxy even if the resolution is connected, directly or indirectly, with the remuneration of the KMP which includes the Chairman.

The Chairman of the Meeting intends to vote undirected proxies in favour of Resolution 1.

The Company will disregard any votes cast on Resolution 3 by:

- (a) a person who participated in the issues and received March Shares and/or April Shares;
- (b) a person who might obtain a benefit, except a benefit solely in the capacity of a holder of Shares if the resolution is
- (c) an Associate of any person described in (a) or (b).

However, the Company will not disregard a vote if:

- it is cast by a person as proxy for a person who is entitled to vote, in accordance with the directions on the proxy form; or
- (ii) it is cast by the Chair as proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides.

Other information

An Explanatory Memorandum accompanies and forms part of this Notice of Meeting.

All Shareholders should read the Explanatory Memorandum carefully and in its entirety. Shareholders who are in doubt regarding any part of the business of the Meeting should consult their financial or legal adviser for assistance.

Voting by proxy

Any Shareholder entitled to attend and vote at this Meeting is entitled to appoint a proxy to attend and vote instead of that Shareholder.

The proxy does not need to be a Shareholder of the Company.

A Shareholder who is entitled to cast 2 or more votes may appoint 2 proxies and may specify the proportion or number of votes each proxy is appointed to exercise. If no proportion or number is specified, each proxy may exercise half of the Shareholder's votes.

Explanatory Memorandum

This Explanatory Memorandum sets out further information regarding the proposed Resolutions to be considered by Shareholders of QV Equities Limited (the Company) at the 2017 Annual General Meeting to be held commencing at 10.00 am (AEDT) on 1 November 2017 in the Adelaide Room at the Sofitel Sydney, 61-101 Phillip Street, Sydney, NSW.

The Directors recommend that Shareholders read this Explanatory Memorandum before determining whether or not to support the Resolutions.

If you are in doubt about what to do in relation to the Resolutions contemplated in the Notice of Meeting and this Explanatory Memorandum, it is recommended that you seek advice from an accountant, solicitor or other professional adviser.

Financial statements and reports

Under Section 317 of the Corporations Act, the Company is required to lay its Annual Financial Report, Directors' Report and Remuneration Report before its Shareholders at its Annual General Meeting. The Annual Financial Report is submitted for Shareholders' consideration and discussion at the Meeting as required. Meeting attendees are invited to direct questions to the Chairman in respect of any aspect of the report they wish to discuss. No resolution is required for this item.

Representatives of the Company's auditor, Pitcher Partners Sydney (**Pitcher Partners**), will be present for discussion purposes on matters of relevance to the audit.

Shareholders may view the Company Annual Financial Report on its website at www.qvequities.com.

Resolution 1 - Remuneration Report

Board recommendation and undirected proxies. The Board recommends that Shareholders vote in **FAVOUR** of Resolution 1. The Chairman of the **Meeting intends to vote undirected proxies in FAVOUR of Resolution 1.**

Resolution 1 provides Shareholders the opportunity to vote on the Company's Remuneration Report. The Remuneration Report is contained in the Company's Annual Financial Report. Under Section 250R(2) of the Corporations Act, the Company must put the adoption of its Remuneration Report to a vote at its Meeting.

This vote is advisory only and does not bind the Directors or the Company.

The Board will consider the outcome of the vote and comments made by Shareholders on the Remuneration Report at this Meeting when reviewing the Company's remuneration policies. If 25% or more of the votes that are cast are voted against the adoption of the Remuneration Report at two consecutive Annual General Meetings, Shareholders will be required to vote at the second of those Annual General Meetings on a resolution (a "spill resolution") that another Meeting be held within 90 days at which all of the Company's Directors other than the Managing

Director must be offered up for election.

KMP Members (including Directors) and their closely related parties must not cast a vote on the Remuneration Report, unless as holders of directed proxies for Shareholders eligible to vote on Resolution 1.

The Company encourages all Shareholders to cast their votes on this Resolution 1. The Chairman will vote all undirected proxies in favour of this Resolution 1. If you wish to vote "against" or "abstain" you should mark the relevant box in the attached proxy form.

Resolution 2 - Re-election of Anton Tagliaferro as a Director

Board recommendation and undirected proxies. The Board (excluding Anton Tagliaferro) recommends that Shareholders vote in **FAVOUR** of Resolution 2. The Chairman of the Meeting intends to vote undirected proxies in **FAVOUR** of Resolution 2.

Under Rule 15.6 of the Constitution one-third of the Company's Directors, or the whole number nearest but not exceeding one-third, must retire by rotation. As the Company has five Directors, this means that at least one Director should retire by rotation annually.

Resolution 2 provides for the re-election of Anton Tagliaferro as Director of the Company in accordance with Rule 15.6 of the Company's Constitution.

Anton Tagliaferro joined the Board on 30 April 2014 and has over 30 years' experience in the financial services industry. Mr Tagliaferro is currently a Director of Investors Mutual Limited.

Resolution 3 - Ratification of Prior Issue of Shares

Board recommendation and undirected proxies. The Board recommends that Shareholders vote in **FAVOUR** of Resolution 3. The Chairman of the Meeting intends to vote undirected proxies in **FAVOUR** of Resolution 3.

Background to Resolution 3 - institutional placement

On 2 March 2017 the Company announced that it had successfully completed an institutional share placement of fully paid ordinary shares to raise \$35 million (Placement). The Placement was priced at \$1.22 per share and 28,688,524 shares were issued on 21 March 2017 to institutional investors (March Shares).

A further placement to professional and sophisticated investors of 4,537,787 shares for \$5.5 million (before costs) priced at \$1.22 per share was also successfully completed, with the shares issued on 7 April 2017 (April Shares).

Net proceeds from the March Shares and April Shares have been used to invest in ASX-listed securities in accordance with the Company's investment strategy.

Resolution 3 proposes that Shareholders of the Company approve and ratify the prior issue and allotment of the March Shares and April Shares.



All of the March Shares and April Shares were completed utilising the Company's existing capacity under ASX Listing Rule 7.1. Listing Rule 7.1 allows the Board of an ASX listed entity to issue up to 15% of the Company's issued capital in any 12-month period without the approval of the Shareholders of the Company.

ASX Listing Rule 7.4 sets out an exception to Listing Rule 7.1 which provides that where a company in a general meeting ratifies the previous issue of securities made pursuant to Listing Rule 7.1 (and provided that the previous issue did not breach Listing Rules 7.1), those securities will be deemed to have been made with Shareholder approval for the purpose of Listing Rule 7.1.

The effect of approval of this Resolution 3 is to allow the Board of the Company to issue additional securities within the 15% limit under Listing Rule 7.1 instead of having to wait 12 months after the issue.

Information required by ASX Listing Rule 7.5

The following information in relation to the Placement Shares is provided to Shareholders for the purposes of Listing Rule 7.5.

- a) The Company issued the following Shares:
 - i. 28,688,524 fully paid ordinary shares on 21 March 2017 utilising the Company's existing capacity under ASX Listing Rule 7.1; and
 - 4,537,787 fully paid ordinary shares on 7 April 2017 utilising the Company's existing capacity under ASX Listing Rule 7.1.
- b) The issue price of both the March Shares and the April Shares were \$1.22 per share.
- c) All of the March Shares and April Shares were fully paid on issue and ranked equally in all aspects with all existing fully paid ordinary shares previously issued by the Company.
- The March Shares and April Shares were issued to institutional investors
- The Company intends to use the funds raised to invest in ASX-listed securities in accordance with the Company's investment strategy.

Questions and comments by Shareholders at the meeting

In accordance with the Corporations Act, a reasonable opportunity will be given to Shareholders - as a whole - to ask questions or make comments on the management of the Company at the Meeting.

Similarly, a reasonable opportunity will be given to Shareholders - as a whole - to ask questions to the Company's external auditor, Pitcher Partners, relevant to:

- (a) the conduct of the audit;
- (b) the preparation and contents of the audit;
- (c) the accounting policies adopted by the Company in relation to the preparation of its financial statements; and
- (d) the independence of the auditor in relation to the conduct of the audit.

Shareholders may also submit a written question to Pitcher Partners if the question is relevant to the content of Auditor's Report or the conduct of its audit of the Company's financial report for the year ended 30 June 2017.

Relevant written questions to Pitcher Partners must be submitted no later than 7:00 pm (AEDT) on 25 October 2017. A list of those questions will be made available to Shareholders attending the Meeting. Pitcher Partners will either answer questions at the Meeting or table written answers to them at the Meeting. If written answers are tabled at the Meeting, they will be made available to Shareholders as soon as practicable after the Meeting.
