Investment return – September, 2017

In the interests of keeping the market informed on a timely basis of the investment returns of the Global Value Fund portfolio, the manager produces an interim estimate for release to the market ahead of the more detailed monthly investment update and NTA report.

This estimate refers only to changes in the portfolio's value over the month through the manager's investment activities, after the deduction of operating costs and management fees and before any provisions for taxes.

The manager estimates that the investment return for the Global Value Fund was +1.3% during September.

Including tax payments made during the month, the manager estimates that the pre-tax NTA per share at the end of September was \$1.1073.

FY2017 Final Dividend

Shareholders are reminded that GVF's shares will trade ex-dividend this Friday, 6 October 2017. Shareholders on the Company's register as at 9 October 2017 will be entitled to the FY2017 final dividend of 3.15 cents per share.
