### \$2.87M PLACEMENT & APPOINTMENT OF EXPLORATION MANAGER

Further to the ASX Announcement released on 30 October 2017 Coppermoly Ltd (**Coppermoly**) is pleased to announce that it has completed the procedures for the allotment of the Initial Placement of 164,072,670 new fully paid ordinary shares in Coppermoly (**Shares**) to Shenzhen Beilite Jades Limited (**Beilite**) to raise \$1,722,763 (before costs).

The placement is the first stage of a Placement Agreement with Beilite to raise a total of \$2,870,000 (before costs).
