

## WAM Leaders portfolio increases 4.6% in October 2017

To assist WAM Leaders optionholders in making an informed decision regarding the exercise of their options (ASX: WLEO), WAM Leaders Limited (ASX: WLE) today announces its October 2017 investment portfolio performance and estimated pre-tax net tangible assets (NTA).

The investment portfolio increased 4.6% in October 2017, outperforming the S&P/ASX 200 Accumulation Index. The estimated pre-tax net tangible assets (NTA) for the month is \$1.21\* per share.

For the calendar year to date, the investment portfolio has increased by 11.3%, outperforming the Index by 3.3%. WAM Leaders looks forward to announcing its detailed October 2017 investment update on 6 November 2017.

### Options

WAM Leaders options can be sold before they cease trading on 13 November 2017 or exercised before they expire on 17 November 2017. More than one-third of all options have already been exercised. If you do not take any action your options will expire and have no value.

Optionholders are entitled to purchase additional WAM Leaders (ASX: WLE) shares at \$1.10 without paying brokerage costs, representing a 9% discount to the estimated pre-tax NTA. Shares in WAM Leaders closed at \$1.135 on 31 October 2017. Optionholders who exercise their options will receive the 2.0 cents per share fully franked final dividend. WAM Leaders options (ASX: WLEO) closed at 2.5 cents on 31 October 2017.
