7 November 2017**RED METAL COMPLETES SHARE PLACEMENT**

The Board of Red Metal Limited (ASX: RDM) is pleased to advise that the share placement announced on 1 November 2017 has now been completed. The Company confirms the allotment of 13,215,000 shares at an issue price of \$0.14 each to raise \$1.85 million. The shares were placed to selected Australian institutions and professional investors. Veritas Securities Limited acted as lead manager to the issue.

The proceeds of the Placement will be used to fund the first-pass drill program at the Lawn Hill project, as well as to advance the Company's other active Australian base metal projects and for working capital purposes.

The Company has also issued 200,000 shares following the conversion of 200,000 incentive options.

An Appendix 3B is attached with respect to the new securities issues and the Company gives notice that:

- it issued the securities without disclosure to investors under Part 6D.2 of the Corporations Act 2001 ("Act");
- this notice is being given under section 708A(5)(e) of the Act;

- as at today's date there is no other information that is excluded information which is required to be set out in this notice pursuant to section 708A(6)(e) of the Act.

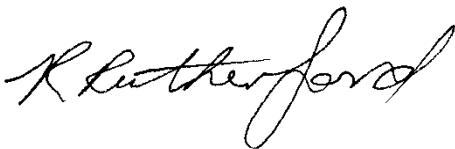

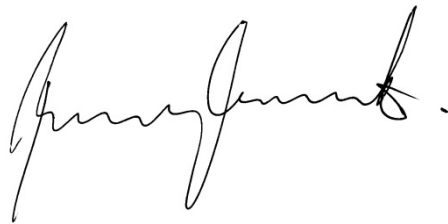
1. The dilution to existing shareholders as a result of the shares issued pursuant to the Placement under Listing Rule 7.1A (13,215,000) was 6.29%.
