## **YOUR OPTIONS TO ACQUIRE CHINA MAGNESIUM CORPORATION LIMITED SHARES AT \$0.05 PER SHARE EXPIRE ON 8 DECEMBER 2017**

We are writing to you as a registered holder of 8 December 2017 options in CHINA MAGNESIUM CORPORATION LIMITED to remind you that the options will expire at 5:00pm (AEDT) on 8 December 2017.

Your option holding may be exercised in whole or in part by payment of \$0.05 for each option by no later than 8 December 2017. If payment is not received by 5:00pm (AEDT) on 8 December 2017 the options will lapse and all rights under the options will cease at that time.

Some of the courses of action available to you as a holder of these soon to expire options are:

- a) Exercise the options on or before 8 December 2017.
- b) Sell your options. Quotation of the options will cease at the close of trading on 4 December 2017
- c) Do nothing (i.e. allow your options to expire). If you do not exercise or sell your options they will expire on 8 December 2017 and your right to subscribe for ordinary shares in CHINA MAGNESIUM CORPORATION LIMITED at \$0.05 per share will lapse.
