A preliminary estimate of the 31 October 2017 Pre-Tax Net Tangible Asset Backing per share was announced on 3<sup>rd</sup> November 2017. We now release the official NTA<sup>1</sup> values.

At 31 October 2017, NTA pre-tax was \$0.9660 and NTA post-tax was \$0.9835.
