Further to the announcement on 2 November 2017, Pureprofile Ltd (ASX: **PPL** or the **Company**) wishes to advise the issue of performance rights for nil consideration to the Lucerne Composite Fund.

These performance rights were issued as part of the agreement for the A\$10 million debt facility and will expire at the end of the term of the facility. The performance rights have been issued on the following terms:

- 950,000 performance rights, which will convert to fully paid-up ordinary shares upon the 60-day volume weighted average price (**VWAP**) of Pureprofile shares reaching \$0.40 per share; and
- 1,150,000 performance rights, which will convert to fully paid-up ordinary shares upon the 60-day VWAP of Pureprofile shares reaching \$0.60 per share.
