Company overview

WAM Microcap Limited (ASX: WMI) is a listed investment company managed by Wilson Asset Management. Listed in June 2017, WAM Microcap provides investors with diversified exposure to a portfolio of undervalued growth companies with a market capitalisation of less than \$300 million at the time of acquisition.

Market overview

The S&P/ASX Small Ordinaries Accumulation Index closed up 3.9% for the month. Once again, the resources sector was the main driver of the Index's performance with the S&P/ASX Small Resources Index up 7.9% for November and up 28.7% for the financial year to date.

During the month the S&P/ASX All Ordinaries Accumulation Index pushed through the 6,000 point mark for the first time since the global financial crisis, largely driven by the energy and mining sectors. The NAB Business survey reported yet another strong outcome in October 2017, with conditions soaring to an all-time high. In contrast, the Westpac-Melbourne Institute index of consumer sentiment registered a 1.7% fall in November 2017. Data from the Australian Bureau of Statistics (ABS) reported Australia's unemployment rate fell to a near five-year low.
