The weekly estimated unaudited pre-tax net asset value before withholding tax on unpaid distributions as at 15 December 2017 was \$1.65* per unit.

The Fund is a long-term investor and does not intend to dispose of its total portfolio. If estimated tax at 35% on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value before withholding tax on unpaid distributions as at 15 December 2017 would be \$1.40* per unit.

These estimates may not take into account all intra-month accruals, which are incorporated in the monthly NTA updates.

Please note that this will be the final NTA estimate for the 2017 calendar year. The next NTA estimate will be released on Wednesday, 17 January 2018.
