**Appendix 3B and Explanatory Note**

Under cover of this letter is the Appendix 3B in respect of the 75 million shares placed pursuant to Kina Petroleum Limited's ASX announcement of 20 December 2017.

The appendix 3B identifies the number of shares quoted on the ASX and the number of shares quoted on the POMSOX.

Note that the number of shares quoted on each exchange includes a transfer of 23,714 shares from ASX to POMSOX, which occurred *after* the Appendix 3B that was lodged by Kina Petroleum Limited on 19 June 2017. Therefore the balance of shares on the ASX and POMSOX immediately prior to the issue of the 75 million shares for which quotation is now sought, is 23,714 less and more (respectively) than shown in the Appendix 3B of 19 June 2017.
