

ECARGO HOLDINGS LIMITED ACQUIRES 45% OF JESSICA'S SUITCASE PTY LTD

January 24, 2018 (HONG KONG): eCargo Holdings Limited (ASX:ECG) ("eCargo" or "ECG") is pleased to announce the completion of the Agreement detailed in the ASX Announcement of January 22, 2018.

As a result of completion of the Agreement, ECG has acquired 45% of the shares in Jessica's Suitcase Pty Ltd ("Jessica's Suitcase") in consideration for the issue to the shareholders of Jessica's Suitcase ("Vendors") of such number of CDIs equal to 15% of the CHESS Depository Interests ("CDIs") in ECG, namely 80,250,000 CDIs with an option to acquire the balance 55% of Jessica's Suitcase.

eCargo has also appointed Ms. Jessica Rudd as a Non-Executive Director to the eCargo Board.

- Appendix 3X detailing the initial Director's interest in ECG of the newly appointed Non-Executive Director, Ms. Jessica Rudd;
- An ASIC Form 603 Notice of initial substantial holding for SB International Investments Pty Ltd; and
- An ASIC Form 604 Notice of change of interests of substantial holder for Mr. John Lau, JL Enterprises Holding Limited and CS China Logistics Limited.
