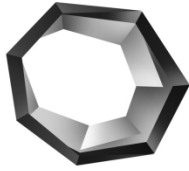
TRADING HALT

Request for Trading Halt

Magnis Resources Limited [**Magnis**] [ASX:MNS] requests that an immediate trading halt be granted by the Australian Securities Exchange [**ASX**] with respect to its ordinary shares.
