Exercise of options

Realm Resources Limited (ASX: RRP) ("**Realm**" or the "**Company**") confirms that it has received notices for the exercise of 10,000,000 options (on a post-consolidation basis) over fully paid ordinary shares in the Company ("**Options**") in accordance with the terms of the Option Deed dated 12 February 2013 between the Company and Taurus Funds Management Pty Limited on behalf of Taurus Resources No. 2 Trust ("**Taurus**").

The Options were issued by the Company under a \$5,000,000 Convertible Equity Linked Facility with the approval of Realm shareholders at the 2013 Annual General Meeting held on 12 February 2013. The Options were issued with an exercise price of \$0.50 (on a post-consolidation basis) with a term of 5 years.

The Company has received the \$5,000,000 aggregated exercise price for the Options and has now issued 10,000,000 shares to Taurus entities, as reflected in the enclosed Appendix 3B. There are no further options held by Taurus.
