## **Beston Global Foods completes its state-of-the-art Mozzarella plant and is now in production**

---

Beston Global Food Company ('BFC' or the 'Company') is pleased to announce that it has completed the installation and commissioning of its state-of-the-art Mozzarella plant at Jervois, South Australia.

The Mozzarella plant is the largest capital expenditure project to date in the company. The final commissioning of the Mozzarella plant represents the culmination of a \$26.5 million investment by BFC into its dairy operations over the last 18 months.

The Mozzarella plant increases the company's dairy manufacturing capabilities and will allow the company to increase its product range to customers through its existing wholesale, food service and retail channels primarily for the domestic and export markets. The Mozzarella line has a production capacity of around 16,000 tonnes per annum of Mozzarella and also provides increased production of its gold medal winning whey products.

BFC's Chairman, Dr Roger Sexton, said that the completion of the Mozzarella plant is a huge milestone for the company in its journey to become a leading Australian food, beverage and nutritional company. "This project is a result of the alignment of the company's investment in infrastructure with its long-term strategy and will ensure that we not only continue to win in our current market segments but also position our dairy platform to win in new markets".

Sean Ebert, BFC's Chief Executive Officer, said that the completion of the Mozzarella plant provides the Company's dairy division with another premium product to sell to customers and marks off one of the Company's key strategic objectives from the outset, namely, to achieve both an increase in the milk throughput at our dairy factories and an increase in the utilisation of the assets employed in this division of the Company. "Prior to the sale and removal of the previous plant at Jervois by the Receivers of UDP, the Mozzarella produced at Jervois had the reputation as being amongst the best in Australia. With the investment which we have now completed, we believe that we will have restored our Jervois factory to its rightful place as being one of the foremost, premium manufacturers of Mozzarella cheese in Australia".

Over the next few months, BFC will be scheduling factory visits to Jervois for any shareholders who would like to inspect our new world class, state-of-the-art Mozzarella factory (and if requested, our Hard Cheese plant at Murray Bridge which is approx. 10km away).
