Appendix 3C – Buyback of Employee Share Plan Shares

Company Announcements ASX Limited By Electronic Lodgement

Please find attached an Appendix 3C in relation to a buy-back and cancellation of 2,116,666 Employee Plan Shares in Realm Resources Limited being the result of employees and former employees no longer being entitled to the shares in accordance with the Realm Resources Limited Employee Share Plan.

These shares have been cancelled and accordingly the Company's number of shares on issue is reduced to 252,759,495 shares.

There will be a cash outlay by the Company of \$100,000 as 250,000 shares were bought back at \$1.015 per share which was used in part to repay the loan of \$0.615 per share (\$153,750 in total). The outstanding loan for the remaining 500,000 shares held by that individual of \$0.615 per share (or \$307,500 in total) will be extinguished by the return and cancellation of the 500,000 shares. There is no cash outlay by the Company for the buy-back of the other 1,866,666 Shares, as a loan was made by the Company to the employees and former employees to fund the original purchase of the Plan Shares and the loan is being extinguished in full by the return and cancellation of the shares.
