BOARD APPOINTS JULIEANNE ALROE AS NEW NON-EXECUTIVE DIRECTOR

She is also the inaugural President of the Queensland Futures Institute, member of Urban Futures Brisbane and the Brisbane Infrastructure Council, a member of the Queensland Climate Advisory Council (QCAC) and the Council of Governors of the American Chamber of Commerce QLD.

Previous board appointments include the position of Chairman of Airports Coordination Australia Ltd and of the Airports Council International Safety and Technical Standing Committee. She was also a Board member of The Queensland Theatre Company, Australia Trade Coast Ltd and the International Grammar School Sydney.

Julieanne has a Bachelor of Economics from the University of Queensland and was granted the Doctor of the Griffith University (honoris causa) in December 2016. She also is a Graduate of the Australian Institute of Company Directors.
