The prior announcement dated 07 Mar 2018 has been revised and reissued following confirmation by BHP Billiton Limited of the foreign exchange rate applied to convert the USD dividend into Australian dollars.

UBS AG, Australia Branch ("**UBS**") issued **BHPISK, BHPISN, BHPISR, BHPISS, BHPIST** & **BHPISU** Series of UBS Dividend Builders over fully paid Shares of BHP Billiton Limited pursuant to the Master Product Disclosure Statement dated 17 Oct 2014 and the relevant Term Sheet for the Series referred to collectively as the "**PDS**".

BHP Billiton Limited recently announced the following Ordinary Dividend:

Correspondingly, the **BHPISK, BHPISN, BHPISR, BHPISS, BHPIST** & **BHPISU** UBS Dividend Builders will commence trading ex-Dividend on 08 Mar 2018 and will have a Dividend Record Date of 09 Mar 2018.

Holders should be aware that BHP Billiton Limited may amend the amount of the Dividend payable (including for changes in foreign exchange rates if a foreign exchange rate is used to determine the Dividend payable in Australia) or revoke payment of the Dividend, prior to the Dividend payment date and Holders are entitled only to the Dividend actually paid by BHP Billiton Limited.

The Dividend amount will be paid to Holders as soon as reasonably practicable after receipt of the Dividend in cleared funds by UBS Nominees Pty Ltd, as Security Trustee, from BHP Billiton Limited (payment to Holders is expected to be made within 5 Business Days of the Security Trustee receiving the Dividend). The Security Trustee is expected to receive such funds on 27 Mar 2018, the Share Issuer's Dividend payment date.

Capitalised terms not otherwise defined in this announcement have the same meaning as that given in the PDS.
