- (c) There were no concessionary fee or other arrangements entered into which have had the result that the effective issue price paid by some allottees differed materially from the price determined by the Bookbuild as announced by GrowthOps;
- (d) There were no arrangements entered into which have had the result that some allottees received a material benefit for agreeing to participate in the Bookbuild at the price determined by the Bookbuild as announced by GrowthOps and which is not received by other allottees; and
- (e) There were no arrangements entered into with associates of GrowthOps or the Lead Manager to avoid a shortfall, or the appearance of a shortfall, in the Bookbuild.

10 ASIC Relief

GrowthOps has sought relief under section 340(1) of the *Corporations Act* 2001 (Cth) ("**Corporations Act**") from the requirement under section 323D(5) of the Corporations Act

that a company's financial year be 6 months long, in order to permit GrowthOps to adopt a first financial half year end of 31 December 2017.

The relief was sought to facilitate timely disclosures in accordance with the general expectations of Shareholders and to enhance market efficiency by enabling Shareholders to compare GrowthOps' results with that of its peers through aligning GrowthOps' reporting periods with the majority of Australian listed companies.

The effect of the relief is to substitute GrowthOps' current financial half year to a 4 month period ending on 31 December 2017.
