

**ASX Release | Chapmans Limited (ASX:CHP)****Securrency Investment Update**

**5 April 2018:** Diversified investment company Chapmans Limited (ASX:CHP) (“Chapmans” or “the Company”) provides the following update in respect of its investment in Securrency Inc. (“Securrency”).

As previously announced, Chapmans entered into an agreement to invest up to US\$4m in leading blockchain finance and securities trading platform Securrency [ASX Announcement: 9 February, 2018]. Chapmans has since advanced US\$1m to Securrency [ASX Announcement: 12 March, 2018], with the option to invest further US\$1m tranches each month for three consecutive months subject to and in line with Securrency’s execution plans to list on the TSX Ventures Exchange (TSX) in the next four months and Chapmans acceptance of listing and pricing terms.

Chapmans has decided to not proceed with the second US\$1m tranche based on Securrency’s execution plans to list on the TSX not proceeding to the satisfaction of Chapmans as at 31 March, 2018.

Notwithstanding the Company’s decision to not proceed with the second US\$1m tranche, Chapmans retains its rights to invest a further US\$2m in Securrency in US\$1m tranches on or before 30 April and 31 May, 2018.

Further, Chapmans confirms that the decision not to proceed with the second US\$1m tranche will not affect the strategic channel partnership agreement referred to in the Company’s ASX Announcement of 12 March 2018. Chapmans advises that it is still working with Securrency to finalise the terms of this arrangement and will update the market in due course once these terms have been finalised.

**Chapmans Executive Director Anthony Dunlop:** “We are very pleased with our US\$1m investment in Securrency to date and look forward to updating the market on the progress of Securrency and our investment in due course.”
