# Appointment of new Director - John H Anderson

Platina Resources Limited ("Platina") is pleased to advise a further appointment to the Platina Board.

Mr John Anderson has agreed to join Platina as a Non-Executive Director. Mr Anderson's appointment complements the current Board of Directors ahead of finalisation of the appointment of a new Chief Executive Officer, which is imminent.

Mr Anderson recently retired from Santos Limited where he was a senior executive for more than twelve years which included roles leading strategic projects, business development, mergers and acquisitions, commercial and marketing and trading. Mr Anderson also had roles leading two of Santos' business units, in Western Australia and the Northern Territory and in Asia Pacific in which he was accountable for all activities from exploration through to development, operations and sales. Mr Anderson is a Graduate of the Australian Institute of Company Directors and is an Executive Consultant for Deloitte Consulting.

#### Platina Chairman, Brian Moller, commented:

"I am delighted to welcome John to Platina. John has a strong reputation and his extensive executive experience will be very valuable to Platina as it progresses the commercialisation of its assets".

It is proposed, subject to shareholder approval, to issue Mr Anderson (or his nominee) 2 million unlisted options exercisable at 20 cents each on or before 31 December 2019. It is proposed that the unlisted options will vest in the event of the Company's share price trading at a VWAP of at least \$0.25 for a period of 10 trading days. Full details of the terms of the unlisted options will be included in the notice of meeting to be sent to shareholders. The proposed meeting date has not yet been determined.
