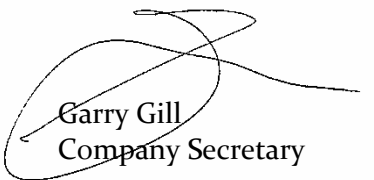

Cannindah Resources Limited (**Company**) hereby provides notice to the ASX for the purpose of section 708A(5)(e) of the Corporations Act that it has issued 5,000,000 fully paid ordinary shares at for a total consideration of \$150,000 on 13 April 2018. The issues were made without disclosure to investors under Part 6D.2 of the Corporations Act.

Cannindah Resources Limited financial statements for the half year ended 31 December 2017, noted that the Company was continuing to hold discussions with interested parties from both domestic and international entities regarding the Mt Borium Project and the Mt Cannindah Project. At the date of this notice no agreements have been signed in regard to either of these matters.

The financial statements also noted that the Company is in constant communications with the Lender. The parties continue to investigate a number of options with respect to the repayment of its loan facility including potential asset sales, capital raisings and further loan extensions.
